MINOR RELEASE

I, as the parent/guardian of Minor (as defined below), hereby irrevocably grant to Vox Media, LLC (“Vox Media”) and each of its licensees, successors and assigns, the right but not obligation to photograph, film, interview and/or otherwise make audiovisual recordings of the Minor (the “Recording”), and grant Vox Media the worldwide right to use and to authorize the use of the Minor’s name, likeness, biographical information, voice, and image (collectively, “Minor’s Personal Attributes”) in connection with the Recording in any or all of the following: (i) on and in and in connection with *New York* magazine (the “Magazine”), including without limitation any syndication of material from the Magazine, and in any Magazine anthology or printed collection; (ii) on and in any and all websites and other digital properties owned and/or operated by Vox Media, including without limitation *nymag.com*, *Grub Street*, *Vulture*, *Daily Intelligencer*, and *The Cut* (each a “Vox Media Website”), and in connection with the syndication and third-party distribution of material from the Vox Media Websites, and (iii) in connection with the advertising, marketing, and promotion of any or all of the foregoing, including in materials advertising or promoting the goods and services of Vox Media.

I acknowledge Vox Media shall own all rights in and to the Recording and I and I on behalf of Minor expressly and irrevocably waive any right to approve any use of the Minor’s Personal Attributes and the Recording in accordance with this Release. I and I on behalf of Minor expressly and irrevocably waive any right to seek injunctive relief and acknowledge the sole remedy for any claims against Vox Media, connected with the rights granted herein, shall be an action at law to recover actual damages.

I and I on behalf of Minor hereby unconditionally waive, release and hold harmless Vox Media and its licensees, successors and assigns, and each of its and their respective officers, directors, owners, employees, agents and representatives, from any claims or actions arising out of or in connection with the use of Minor’s Personal Attributes or the Recording in accordance with this release.

This release will be governed by the laws of the State of New York, regardless of the place of its physical execution, and will be binding on my legal representatives, heirs and assigns.

I represent and warrant that (i) the exercise of the rights granted herein will not violate or infringe upon the rights of any third party; and (ii) I am a legally competent adult and parent or legally appointed guardian of Minor and have every right to contract for Minor in regards to the rights granted herein; and (iii) I have read this Release prior to signing and understand its contents.
